- **Ethical Conduct:** No harassment of wildlife, littering, or reckless behavior allowed. Alcohol, drugs, or firearms misuse will result in immediate removal from the activity.
- **Confidentiality:** Any personal stories or experiences shared during Foundation events are to be respected and kept confidential unless express permission is given.
